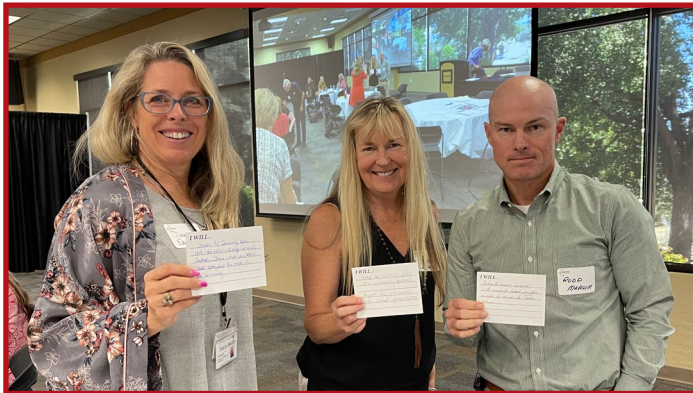

IMPACT

In the year 2022, we celebrated the organization's **60th Anniversary**.

We had one of our busiest years yet, continuing to highlight the critical importance of Arizona Town Hall's mission of educating, engaging, connecting, and empowering people to come together to solve pressing issues.

During 2022 Arizona Town Hall engaged nearly 4,000 people in the following ways:

- 26 interactive community and future leaders town halls on *Mental Health, Substance Use, and Homelessness*.
- 6 programs on *Creating Vibrant Communities*.
- 2 statewide town halls on *Creating Vibrant Communities* and *Mental Health, Substance Use, and Homelessness*.
- 7 training programs on leadership and facilitation techniques, including programs with global leaders.
- 2 *Cross-Border Connecting* virtual programs.
- 6 interactive consulting programs on topics that ranged from economic resiliency, workforce development, local government planning, and organizational strategic planning.

Arizona Town Hall was able to achieve this level of engagement in no small part thanks to high-level professional volunteers who tirelessly aid the organization's small paid staff. In 2022, over 80 unique volunteers clocked approximately over 2,300 hours.

These gatherings were designed to galvanize and empower participants to be constructive members of their communities, to engage with others to address pressing issues, and to implement changes not only locally but also on a statewide and regional basis.

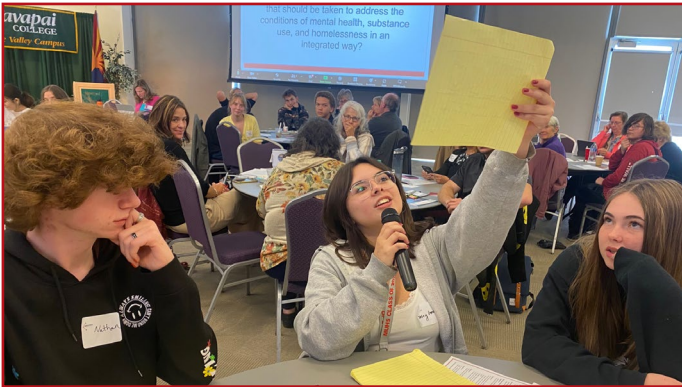

In 2022, Arizona Town Hall reinvigorated in-person programming and offered hybrid and virtual opportunities for engagement. We expanded the reach of the organization's mission with programs across all corners of the state and internationally.

The *Cross-Border Connecting* series deepened business and cultural connections with virtual offerings that covered the impact of agriculture on the border and binational workforce development.

Informed by the comprehensive background report, community and future leaders town halls on *Mental Health, Substance Use, and Homelessness* engaged diverse participants from Bullhead City, Casa Grande, Cave Creek/Scottsdale, Clarkdale, Flagstaff, Florence, Kingman, Payson, Phoenix, Prescott, Show Low, Sierra Vista, Thatcher, Tucson, Yuma, and many more areas of the state. The statewide town hall was held in person in Tempe, AZ and virtually November 14-16, 2022.

Programs on *Creating Vibrant Communities* connected people to needed resources, set priorities for continued success, and initiated action steps for impact.

All of these programs captured input from Arizona's many diverse communities and empowered participants to take action on their recommendations. Reports of recommendations from programs are widely distributed to local stakeholders, community groups, and elected leaders as valuable resource materials.

MISSION-FOCUSED RESILIENCE

CELEBRATING 60 YEARS OF CONSENSUS

In 2022, Arizona Town Hall celebrated 60 years as one of Arizona’s most longstanding and trusted non-partisan sources for Arizona policy solutions. Founded in 1962, the organization is recognized by national and international groups, its unique process creates connections and strengthens communities while providing forums for resolving contentious and complicated issues.

To celebrate this landmark, Arizona Town Hall launched the 60-by-60 Campaign to task its members to raise at least \$216,000 in new donations for sustaining the mission of Arizona Town Hall—promoting the consensus-based discourse that creates stronger communities. The first 60 to make this commitment join the 60 Cubed Society as a Founding Member.

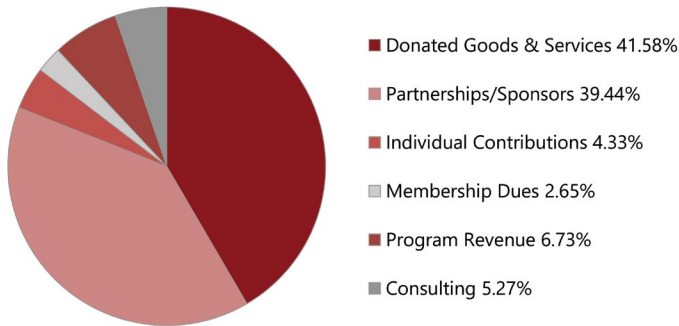

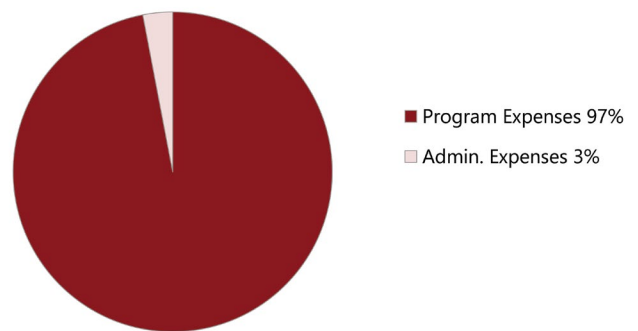

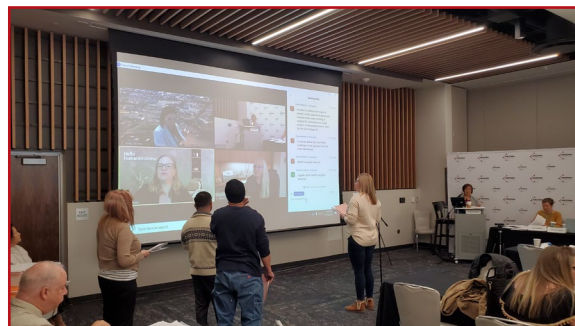
TOP 10 REASONS TO SUPPORT ARIZONA TOWN HALL
